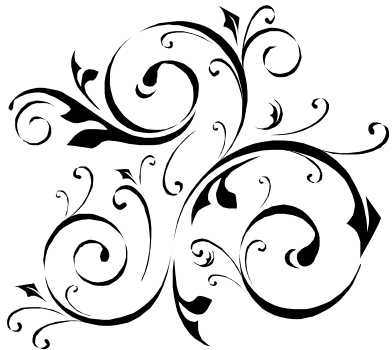

**Franklin Parish Title I**  
**Parental Involvement Policy**

Franklin Parish recognizes the importance of parental involvement in the goal of academic excellence for every child. Parental Involvement has been a major component in the Title I program since its inception in the early 1970's. The Franklin Parish School Board recognizes that parental involvement must be a priority for children to learn and achieve academic success. Parents are to be made aware of what is going on in the school, how their children are doing, and the quality of education their children are receiving. This document contains the Franklin Parish Title I Parent Involvement Policy and several notices for your information. Please review them carefully and keep them for future reference.

**Notice to Parents on Professional Qualifications of their children's teachers and paraprofessionals**

The No Child Left Behind Law enacted on January 8, 2002, gives parents the right to know and request specific information about the professional qualifications of their children's teachers and paraprofessionals. The federal law allows you to request and receive in a timely manner certain information about your children's classroom teachers. Parents will receive written notification in a timely manner if their child is assigned a teacher for four or more consecutive weeks who is not "highly qualified". Parents may request a meeting with teachers and the principal to discuss their concerns.

Upon your request, the schools that your children attend will provide the following information about your children's teachers:

- Whether the teacher has met state qualifying and licensing criteria for grade levels and subject areas he or she teaches.
- Whether the state has waived qualification or licensing criteria and the teacher is teaching under emergency or other provisional status.
- The teacher's baccalaureate degree major and any graduate degree or certification including the field of discipline of the degree and certification.
- Whether the child receives services from paraprofessionals and, if they do, their qualifications.

If you would like to know the professional qualifications of your child's teacher, please contact the principal of the school that your child attends.

### **FRANKLIN PARISH SCHOOL SYSTEM TITLE I PARENTAL INVOLVEMENT**

Because Franklin Parish School Board believes that public schools belong to the people of the parish, strong efforts will be made to involve parents and the community in the preparation of students. Active parental and community involvement enhances and ensures high expectations and standards in the education arena. Through active parent participation and increased knowledge, more understanding and support for the education process is garnered from the home and community. The Central Office as well as local school sites will provide opportunities and encourage parents to become actively involved in the learning process of their children.

Parents will be encouraged to be involved in the joint development of and amendments to the District Plan, Title I School wide Plans, and the process of school review and improvement.

- Encourage administrators and teachers of preschool programs to schedule classroom visits to kindergarten classes and meet teachers prior to entering kindergarten to ensure a smooth transition for students

#### **Evaluation Methods:**

Use a survey to conduct an annual evaluation of the content and effectiveness of the parent involvement program to identify ways of improving the academic quality of schools and determine barriers to greater participation. Parents will be given evaluation forms to complete after all parent involvement activities throughout the year to assess the effectiveness of activities and make adjustments as needed to plan more effective activities.

The District Advisory Council will assist in designing more effective parent involvement activities.



## **Build the schools' and parents' capacity for strong family**

### **Involvement**

- Assist schools in providing information to parents that will help them understand state's academic content standards, state and local academic assessments, the components of the local parent involvement program, and how to monitor a child's progress and work with educators to improve academic achievement.
- Provide materials and training at the school sites to help parents work with their children to improve their children's achievement. Materials and training provided to parents are in a language and format that parents can understand.
- Inform teachers, pupil services, personnel, principals, and other staff of the value and utility of contributions of parents and how to build relationships with parents as equal partners in the education process.
- Provide parents with Home and School Connection publications, and other resources to strengthen awareness of the value of parents' contributions.
- Provide a district parent training session on topics of interest identified by parents.
- Provide a parent center at the Media Center equipped with computers for parent use and stocked with a variety of materials available for home check out.
- Provide a workroom with materials for parents to construct instructional aides to enhance student achievement.

### **Coordinate and integrate Part A Title I family involvement strategies with other programs, e.g. Head Start and other state-operated preschool programs.**

- Encourage administrators and teachers of elementary schools to collaborate about curriculum.
- Schedule and announce location and time of preschool round up/registration.
- Encourage administrators and teachers to invite parents of children in preschool programs to parent involvement activities

## **Schools are required to have an annual meeting at school site to inform parent of the following:**

1. School's education programs including curriculum in use, the forms of academic assessment used to measure student progress, and what level students are expected to meet. Assistance will be provided to parents in the understanding of state assessments and the Louisiana Accountability System

**High School students will take End-of-Course tests in six subjects:**

**Algebra I, Geometry, English II and III,**

**Biology, and U.S. History.**

**High School student in the eleventh grade will take ACT series,**

**WorkKeys- Grade 11 as applicable**

To earn a standard high school diploma, students must earn a score of Fair or above on three End-of-Course tests: including one in each category-Algebra I or Geometry, English II or English III, and Biology or U. S. History.

There are four levels students taking the **End-of-Course (EOC)** can score.

**Excellent**— A student demonstrates superior performance of the course content.

**Good**—A student demonstrates mastery of course content and is well prepared for the next level of coursework in the subject.

**Fair**—A student demonstrates only the fundamental knowledge and skills needed for the next level of course work in the subject.

**Needs Improvement**— A student does not demonstrate the fundamental knowledge and skills needed for the next level of coursework in the subject.

Multiple pathways are being implemented in the high school to ensure college and career readiness for all students. For additional information on these options, you can contact the principal of Franklin Parish High School.

- Each school shall jointly develop with parents a written parental involvement policy and provide a copy of the policy to parents at school meetings and at the school's parent center.
- Each school is required to have parent(s) serve on the Title I Schoolwide Program planning team.
- Each school is required to conduct a parent awareness meeting for input in the Title I program.
- Each school will provide frequent reports to parents on their children's progress
- Each school will inform parents of the opportunity to access the Student Progress Center enabling them to view their child's grades, attendance and discipline record. A link is provided on the Franklin Parish website, [www.fpsb.us](http://www.fpsb.us).
- Each school will inform parents of the parent center/area where materials are available for parents to assist in the improvement of student achievement at the school site.
- Each school is required to provide parent activities offered at various times of the day to encourage parent participation. Parents will receive invitation/notice of meetings and be encouraged to attend these activities, e.g. memos sent home, newspaper announcements, newsletters, etc.
- Each school should involve parents in the planning, review, and improvement of parent involvement programs.

**Provide the coordination and technical assistance to assist participating schools in planning and implementing effective family involvement programs to improve student academic achievement and school performance.**
