

#### MENTOR TEACHER/CONTENT LEADER CERTIFICATION APPLICATION PACKET INSTRUCTIONS

The instructions and checklist outlined in this application are designed to facilitate the process of obtaining certification which will allow you to serve as a Content Leader and/or a Mentor Teacher.

**Submitting application:** Please submit the following items as a single PDF file through the online <u>educator certification</u> <u>portal</u>. The following items are required as part of a complete application packet and must be signed and dated with current date:

- 1. Copy of Applicant's Social Security Card & Driver's License/Official Photo ID (required with every application)
- 2. Application form with all information provided, signed and dated within the last 90 days
- 3. Professional Conduct form with all questions answered, signed, and dated by the applicant
- 4. Copy of Online Payment Confirmation email or screenshot Use Processing Fee Schedule to determine amount due. Payment is non-refundable and does not guarantee certification but is used for review of submitted documents. Payments may be made through the TeachLA Live! portal account. The email confirmation or payment success screen is required to be included with the application. The confirmation number alone is not accepted. Applications that do not include the email confirmation or payment success screen will be returned without processing.
- 5. Qualifying Certification Documentation as follows for the requested areas:

- Have at least two years of successful teaching if serving in a charter school (verified in the certification database at LDOE) -OR- a valid type C, level 1 or higher Louisiana teaching certificate (as verified in the certification database for add-on endorsement)
- Copy of completion document indicating successful completion of a BESE-approved content leader training program
- Copy of content leader assessment series completion document from Bloomboard or from the training provider when assessment was administered by the provider
- Have a valid type C, level 1 or higher Louisiana teaching certificate (as verified in the certification database for add-on endorsement) –OR- Have at least two years of successful teaching if serving in a charter school (as verified in Compass Information System and/or LEADS as effective teaching evaluations) –OR- Non-certificated teacher serving in a nonpublic school with at least two years successful teaching with effective local personnel evaluations
  - Fulfill one of the following qualifying options, providing the documentation noted:

#### **Mentor Teacher**

(Endorsement valid as long as teaching certificate is valid)

(Ancillary valid 5 years, renewable with effective evaluations)

- Successfully complete a BESE-approved Mentor Teacher training program documented with completion certificate from program provider –AND- Passed Louisiana Mentor Teacher assessment series documented with completion certificate from Bloomboard
- Hold a valid National Board Teacher Certification (NBCT) –AND- Passed the coaching-related components of the Louisiana Mentor Teacher assessment series documented with completion certificate from Bloomboard
- Hold Leadership certification (educational leadership eligibility or EDL certificate/endorsement or any one of the leadership endorsements preceding current certification structure including Super. of Student Teaching)
- Hold current National Institute for Excellence in Training (NIET) Teacher Evaluator Training Certification
- Hold Louisiana Educator Evaluator certification (effective August 20, 2024)
- Hold current CLASS® Observers credential

(Valid 1 year nonrenewable Ancillary Certificate)

- Hold a valid type C, level 1 or higher Louisiana teaching certificate —or- have at least two years of successful
  teaching if serving in a charter school (verified in the certification database at LDOE)
- Verification letter/document indicating enrollment in a BESE-approved mentor training program
